- **3. Essential Qualifications:** Bachelor of Engineering or Technology in Computers /ICT/IT or equivalent
- **4. Experience**: Minimum experience of one year in data management, analytics, ML, AI etc. Experience can be waived off for deserving candidates with PG Degree in Engineering or Technology (M.Tech) in above mentioned areas.
- 5. Age 30 years as on last date of submission of the application i.e. 20th August, 2021
- **6. Nature of Duties**: Data management, data analytics, creating and managing online course management systems, creative recording of lectures and uploading on course, responsibility also includes designing and maintaining the website time to time.

#### 7. Consolidated Remuneration:

The IT Scientist will be paid Rs. 80,000/- p.m. (all inclusive). The amounts indicated above are all inclusive and would include all taxes also (if any). No other incidental expenses viz. transport, telephone, etc. would be paid. The place of work will be at New Delhi but the said engagement may involve the liability to travel within and outside Delhi in relation to work.
